2018 UUWF Justice for Women and Girls Sermon Award Winner



The Justice for Women and Girls Sermon award panel of the Unitarian Universalist Women's Federation is pleased to announce that the 2018 winner is Clare Fortune-Lad, the Director of Religious Education at the UU Church of

Haverhill, Massachusetts.

Her sermon "#Me Too, Now What?" will be delivered at this year's UUA General Assembly in Kansas City, Missouri, as part of a program "Women are Called to Preach."

In addition to Clare Fortune-Lad's sermon and the awarding of a \$500 prize, there will be an interactive dialogue on ways that "all are called" (the theme of this year's GA) to build a movement for gender equity through a spiritually-sustaining lens.

This program is scheduled for 11:15 AM-12:15 PM on Friday, June 22.

"It was such an honor to receive the UUWF Sermon Award," Fortune-Lad says. "It will be gratifying to spread this message to so many more folks from across the country."

It will be her first GA.

This is Clare's second year with the Haverhill UU congregation and she has been energized by her work expanding the OWL program and engaging in racial and immigration faith federation work "for young and old alike."

Clare was a leader in helping her family to decide to join the Sanford, Maine UU congregation when she was three years old, and was an active member there until her recent move to Massachusetts.

Clare worked for many years as a community educator at a Domestic Violence Center in Southern Maine. She earned her Masters in Public Administration from the University of Colorado Denver with a concentration in Gender-Based violence.

The 2018 sermon award judges were UU ministers Beth Dana, Marti Keller and Theresa Ines Soto; director of music Amber Fetner; past UUWF Board president Kirstie Lewis, and congregational leader and social justice activist Debra Greenwood.

The UUWF sermon award is a project of the New Prophetic Sisterhood UU (NPSUU), a network of UU woman-identified religious professionals who covenant to affirm and promote justice and equity for women and girls, and to lift up diverse feminisms through awareness building and public witness.

#TimesUpWendys – Mobilization Against Gender Violence in the Fields



In the last few months, the #MeToo and #TimesUp movements have exploded across the United States and around the world, bringing attention to the sexual harassment and violence that has been concealed behind closed doors. Voices that were once only whispers have been amplified and in unison, women have mobilized together, shouting across rooftops, that they will no longer allow these abuses and violations to continue.

One powerful group of organizers that have also been reclaiming their voices are the Coalition of Immokalee Workers (CIW). Based out of Immokalee, Florida, the CIW is a self-described, "worker-based human rights organization" that has been "internationally recognized for its achievements in the fields of social responsibility, human trafficking, and gender-based violence," directly impacted the lives of farmworkers for over 20 years.

Most recently, the CIW has been working on a program, the Fair Food Program (FFP) in Florida to end sexual harassment for farmworker women who have endured sexual violence in the fields. Through this program, the CIW was able to "put an end to sexual harassment and assault for tens of thousands of workers by harnessing the purchasing power of more than a dozen of the world's fast largest retail food companies, including all of the major fast-food brands."

Despite these great victories, Wendy's remains one company that has refused to be part of the FFP and continues to honor the human rights of farmworkers, by shifting its Floridian tomato suppliers and purchases to Mexico. For this reason, the CIW is leading a massive campaign and mobilization from March 11-15th, the *Freedom Fast: Breaking Our Silence to Stop Sexual Violence in the Fields*. In New York City, on **March 15th**, farmworkers will participate in the #TimesUpWendys March for justice, asking for an end to the sexual violence experienced by women farmworkers in the field.

Given our mission to advance justice for women and girls, the UUWF has decided to help amplify this powerful event led by the women who are directly impacted by these grave women's rights violations. In order to support to directly support, we ask you to consider the following actions:

UUWF Justice and Advocacy

Our mission includes advocating for women and girls. We do this through adding our name and our voice to statements, letters, legal briefs and other acts of public witness. We do this as the organization of UU women in this country and we do it to model for UU congregations and groups of women within them, the ways in which they can amplify the call for gender justice and equity.

Recent actions:

On February 20, under the auspices of the Interfaith Healthcare Coalition and the Interreligious Working Group on Domestic Human Needs, we signed on to a letter to Congress "expressing our deep concern about proposals to undermine Americans' basic living standards" by imposing working requirements on essential anti-poverty programs. These programs: Medicaid, The Supplemental Nutrition Assistance Program (food stamps), and housing vouchers assist millions of Americans on the path to self sufficiency.

"Onerous requirements," the letter declared, "would only create barriers for America's most vulnerable to receiving medical treatment, nutritious meals and living in safe homes. Among those impacted would be millions of women and their children.

"While our religious traditions and practices vary enormously, we are united in the dignity of every human being."

On February 27, we joined **Planned Parenthood Federation of America** and

more than 85 faith based and secular organizations in a letter to the US House and Senate Appropriations committees to "strongly oppose attaching 'ideological policy riders' to ongoing funding resolutions. These attachments to appropriation bills have been used by opponents to comprehensive, accessible women's health programs include:

- Sweeping new religious refusal language allowing employers, insurers and health care providers to deny others' access to abortion.
- A rider blocking patients from getting care at Planned Parenthood health centers.
- A provision to block ongoing and potentially life-saving research involving fetal tissue.
- A provision barring all multi-state plans under the Affordable Health Care Act from covering abortion.

We also oppose the "draconian and ideologically driven funding cuts" proposed in bills passed by the House Appropriations Committee, including to the Title X family planning program, the Teen Pregnancy prevention program, and international family planning and reproductive health initiatives.

Two positions on the UUWF Board will be open as of June, the VP of Communications and the VP for Funding Programs. The UUWF Board of Trustees is a dynamic, committed group of people. We meet in person twice a year, and attend General Assembly.

As part of our work, the UUWF is committed to presenting engaging and empowering workshops and programs each year at the UUA General Assembly. In 2018, the UUWF is dedicated to making the UUA a more accessible experience for all individuals, in particular individuals who identify as women and/or women of color. Workshops included a me too circle where women could share their experiences without interruption or comment. Often it is good to just have someone to listen.


We held a discussion on how language impacts our lives, including the use of "guys" and "girls." Also violent language, like deadline, cut-off, etc.

This was our 40th year – established shortly after the Resolution passed and was originally titled Women & Religion Task Force. There have been more than 40 retreats, though, as we used to gather twice a year. Women traveled from places as far as Eureka and Gilroy – about 350 miles apart!
